Wedding Fayres

If you are planning a wedding fayre, and would like us to attend to speak to couples please let us know of the dates as soon as possible. You would need to provide us with a prominent place to stand and a table.



Legal timeframe for couples

To get married or enter a civil partnership in England or Wales, each person must give legal notice of intention, to the registrar in the district (county) where they live. Regardless of where the couple intend to hold their ceremony, they must both give 28 days' notice (in person) at their local

register office, before the marriage or civil partnership can legally go ahead.

The earliest a person can give notice is 12 months prior to their ceremony. However we prioritise appointments by ceremony dates. This ensures that we can accommodate demand and couples may be asked to contact us at a later date. Notices are valid for one year.

I will email you a leaflet that you can hand out (or email) couples who book a ceremony with you.

This will contain guidance on what they need to do to ensure the ceremony is legal. As soon as

they arrive, I will send them. However in the mean time I thought it would be good to give you an

overview.

Civil Partnerships

I wanted to remind you opposite sex couples can form a civil partnership.

You can take bookings to hold opposite sex couples civil partnerships or same sex couples as your licence covers these types of ceremonies.

Please be aware that the timeslots for ceremonies are 11:00am 12:30pm 14:00pm 15:30pm 17:00pm or 19:00pm

There is nothing you need to do in regards to your licence to hold these ceremonies.

Ceremony and licence fees

All fees are reviewed and revised on the 1st April each year. Once we have confirmation of the new

fees from 1st April 2022 I will let you know.

Licence renewals

All applications are subject to a 21 day consultation period, before approvals can be granted.

If your renewal is due in the next 6 months you can apply to renew anytime from now. You can either email <u>ceremonies@york.gov.uk</u> or you can visit our website to complete the application forms https://www.york.gov.uk/YorkMarriageVenues

Pre-ceremony interview

Please ensure that couples are aware that the pre-interview must be done privately with the registrar. It is really important that this takes place in this way, as personal information will be discussed. The registrars and celebration officers have been reminded to ensure that this occurs privately. The interview takes approximately 15 minutes. After that everyone can re-enter the room.

Reminders

The ceremony must start on time – this can be a challenge for all of us. Every couple is made aware the ceremony starts on time. The old tradition of the bride turning up late is over. Please ensure that you explain to the couple why the ceremony must start of time. There is a cut off time, where the registrars will leave for the next ceremony. The registrar will make the judgement on the day. This will depend on the location and time of next ceremony. To help we have moved the weddings to 1.5 hours apart but traffic is still an issue even if everyone's time keeping is perfect!

Car park spaces – please remember as per the conditions of your licence that 2 car park spaces must be provided for the registrars on the day of the ceremony. They must not be blocked in or unable to park at your venue (unless there are no current car park facilities) as they often have to leave very quickly for the next ceremony.

OUTSIDE/INSIDE CEREMONY

This would be at your venue (must be on the venue grounds). The couple and guests are seated outside for the first part of the ceremony, then the couple and their 2 witnesses are taken to one of your licenced rooms for the 'legal part' (take approx. 5 – 8 minutes) then all return to the guests outside to be announced as the husband and wife/ partners for life.

Please promote other ceremonies we offer that can take place at your venue

MARRY ABROAD, CELEBRATE IN York CEREMONY

This is a GREAT way of inviting guests to celebrate the marriage/CP who couldn't travel abroad for the ceremony to be part of the celebrations. This ceremony is not legally binding in anyway.

NAMING CEREMONY

This is an alternative to a religious blessing/christening and can be a way to celebrate the birth of a new baby, an adoption or welcoming a step child.

RENEWAL OF VOWS CEREMONY

Any couple in a marriage or civil partnership can arrange a ceremony to renew their vows. The ceremony is not legally binding and is purely a celebration of the couple's marriage/love.
